RIVERHEAD SOLAR 2 PRE-CONSTRUCTION NOTICE JANUARY 2022

This notice announces that, on or about January 25th, 2022, Riverhead Solar 2, LLC (Riverhead Solar or Permitee) will commence site preparation and construction of the Riverhead Solar 2 Facility a solar-powered electric generation project located in the Town of Riverhead, Suffolk County, NY (Facility).

Pursuant to the requirements of Section 94-c of the Executive Law and its implementing regulations (19 NYCRR Part 900), this notice is being provided in accordance with Riverhead Solar 2's Siting Permit for a Major Renewable Energy Facility (Permit), issued by the New York State Office of Renewable Energy (ORES), on June 25, 2021. A copy of the Permit (and all public documents filed in this proceeding) may be accessed electronically at the Office of Renewable Energy website, https://ores.ny.gov/permit-applications (Case No. 21-00024) or documents may be inspected at the local document repository at the Riverhead Free Library, 330 Court Street, Riverhead, NY 11901.

BRIEF DESCRIPTION OF THE PROJECT

The Permittee is authorized to develop, design, construct, operate, and decommission a photovoltaic (PV) solar facility in the Town of Riverhead, in Suffolk County, consisting of the following: buried collection line, facility access roads, inverters to convert power from direct current (DC) to alternating current (AC), transformers, fencing around the PV panel arrays; temporary material storage areas, and a generator tie line connecting the collection substation, to the point of interconnection (POI) substation (Edwards Avenue substation). The Facility will interconnect to an existing collection substation and POI, but additional equipment will be added to the collection substation to support interconnection of the Facility. Such equipment includes collection line feeders and breakers, a 34.5 kV bus, main power transformer (to increase the voltage from 34.5 kV to 138 kV), a high-voltage breaker, metering/relaying transformers, disconnect switches, equipment enclosure containing power control electronics, and a lightning mast. The total nameplate capacity of the Facility shall not exceed 36 MW.

Additional phases of construction will follow the site preparation activities and are expected to be completed in 2023. Construction activities shall be limited to 7:00 a.m. to 8:00 p.m. Monday through Saturday unless otherwise authorized by the Permit.


